DISCRETIONARY OVERDRAFT PRIVILEGE SERVICE HAS INCREASED TO \$1000

We know that mistakes happen. That iswhy Community Financial Services FCU offers discretionary Overdraft Privilege Service (OPS).

How does it work?

Overdraft Privilege is a service available to eligible checking members. If you keep your account in good standing, Community Financial Services FCU may pay your overdrafts up to \$1000 for our NSF/ODP fee of \$33.00 rather than returning or denying items to the merchant unpaid. Overdraft Privilege can save you the expense, the hassle and the embarrassment of those unexpected mistakes.

*Payment of overdrafts is discretionary. Some restrictions and fees apply.

We may approve certain transactions that overdraw your account. An overdraft fee of \$33 will be charged for each transaction that overdraws your account. The categories or types of transactions that may overdraw your account include payments, purchases and transfers. Whether your overdrafts will be paid or not is at our sole discretion and we reserve the right not to pay. For example, we typically do not pay overdrafts if your account is not in good standing or if you have too many overdrafts. We reserve the right to require you to repay your overdrafts immediately or on demand.

Easy Mobile Deposits

There's no need to visit our office or the ATM to deposit a check. With Mobile Deposit, you'll save yourself a trip — and give your schedule a break!

Make deposits anytime, anywhere.

All you need is a smartphone or tablet – and our TouchBanking App. Then snap a picture of your check and after a few swipes, your deposit is on the way.
